INTERNET DISTRIBUTOR ACCESS AGREEMENT

1. GENERAL TERMS AND CONDITIONS.

The changes also will appear in this document, which you can access at any time by selecting "Terms & Conditions" in the footer of the site. By accessing a Service after Milwaukee has notified subscribers of a change in this Agreement and posted this change, you agree to be bound by all of the changes.
- c.
